Standard Operating Procedure for Registration to AY 2024-25(Part II):

- 1. Take a printout of the Registration form (a copy of the Registration form is attached to this notice).
- 2. Fill out the necessary information (Personal Details/Tuition Fees Details/Scholarship Details/Hostel Fee Details) in the Registration Form.
- 3. Pay the outstanding fees(if any) and attach the receipt of payment to the registration form.
- 4. Submit the Scholarship form(if applicable) for AY 2024-25 and attach a copy of the same to the registration form.
- 5. Get the Registration form verified and approved by the authorities as mentioned in the registration form. The registration form will be approved by the authorities only if there are no pending dues and the student has submitted the scholarship form.
- 6. Submit the duly signed copy of the Registration Form to the Class teacher to complete the Enrollment Process.
- 7. The concerned class teacher will verify all the details and register the student in the respective class.
- 8. The students who are not availing the facility of Government Scholarship and have already paid the complete Tuition Fees and Hostel Fees need not be required to follow the above procedure. They can directly submit their payment receipts to their Class Teachers and complete the enrollment process.


